The provided data will be processed solely to mediate a job, shall be made available only to authorised employees of the company (companies) in the extent necessary for processing, for the term of the selection procedure, not exceeding one year from the date of their provision. You can revoke your consent to processing at any time.

By sending us your CV with a wish to work with us, you give us a permission to contact you when we have a suitable job for you. We and the organisations which help us with the selection procedure use this information to provide you the job that suits your skills and abilities best. Data are also important for us within the whole selection procedure.

## Out of sight, but stay within reach

Once you entrust us your personal data, you do not give up accessing them. Quite the opposite - you may either correct or supplement the data provided or let them delete at any time if they are no longer needed for the purposes for which they were collected or processed, or if it happens by mistake that they were processed illegally. In accordance with the General Data Protection Regulation (EU) 2016/679, you may request a limitation on the processing of your personal data in special cases, you have the right to data portability and you can also raise an objection, which will be followed by the termination of processing your personal data (unless it is proved that there are serious legitimate reasons for processing, especially if it is the case of possible enforcement of legal claims). If you have any doubts, you can contact the Office for Personal Data Protection.

You can also ask for information whether or, where appropriate, whom, we shared your data within IKEA with. We only store important, relevant and necessary data. We delete all useless data.
